ID Cards

Made from a durable plastic, each standard-sized card is branded to your business and displays all the relevant information about the inductee. If you need to record contractor information and work-times, all cards have a magnetic strip on the reverse side and are encoded with the unique ID for the inductee.

Card Printers

A dedicated onsite card printer enables you to print cards as you need them. Or, if you prefer, we can manage the entire card printing and delivery system for you.

Scanners

From traditional card-swipe systems and rugged hand-held bar-code scanners to bio-scan devices, we can incorporate the perfect scanning technology to suit your needs.

Access Systems

Overall, the Site Access Control System enables you to:

- Control access at entry points to your site
- Integrate to third party security systems
- Control access only to contractors who's company PLI insurance is current (optional when linked to our Document Upload Facility)
- Provide access only to inductees who's induction status is current
- Keep a log of who's on site at any given time, through the site register
- Track contractor hours so you can reconcile your contractors bills to the hours they are actually on site
- Integrate into a kiosk or a computer terminal



Secure access in 8 easy steps

- Step 1: Contracting company registers online for staff induction, then issues passwords to contractors
- Step 2: Inducted contractor arrives at site having completed their induction
- Step 3: Identification is confirmed through Rapid Access
- Step 4: Verification questions are asked and the contractor's photo ID is verified
- Step 5: Inductee's photo is taken by a camera attached to the computer and immediately uploaded to Rapid Access
- Step 6: A photo ID card is then printed on a card printer
- Step 7: Contractor swipes card for entry and details appear on screen
- Step 8: Track site entry with reports of all personnel who have signed in and out of the site within any specified date range

These 8 steps represent an overall example of how the system can work.

Of course, every company's requirements will vary and we will work with you to design the best possible system.
